- Booth requests will be assigned on a first come-first serve basis.
- Each vendor must exhibit, oversee, and remove his or her own booth.
- You will be notified of your exact location the first week of September 2008.
- Vendors will enter the Festival at the intersection of Michigan Avenue and Superior Street.

Show Date/Hour: Saturday, September 20, 10:00 a.m. – 6:30 p.m.

Setup: Saturday, September 20 between 7:00 a.m.-9:00 a.m. Booths must be in place by 9:00 a.m. Vehicles are not permitted back in the exhibit area until after 6:30 p.m. The exhibit is outdoors. Please come prepared for the weather. No pets allowed.

I hereby agree to the above criteria for the Festival of the Forks, and agree that the Greater Albion Chamber of Commerce, the Festival of the Forks, its members & volunteers shall not be responsible for loss of or damage to any personal property. I understand that deposit of my check does not constitute acceptance in the show. If not accepted, the fee will be returned by September 1, 2008. I understand that failure to follow the guidelines of the temporary food establishment license can mean immediate expulsion from this year's Festival of the Forks.
